# **Chumming Regulations**

THE NATURAL Resources Commission adopted chumming regulations for trout and salmon fishing at their July 14 meeting. Effective immediately, anglers were prohibited from using organic chum material (fish eggs, corn, rice, noodles, oatmeal or maggots) on any designated trout stream (Types 1-4). A list of designated trout streams can be found in a current Michigan Fishing Guide or on the DNR Web site, michigan. gov/dnr. "Chumming has become a divisive social issue in recent years as some anglers use fish eggs to attract steelhead," a DNR news release stated. "The DNR's Fisheries Division has assessed that chumming is not causing a negative biological impact at the fish population level."

## **Private Lands Sought For Hunting Access Program**

THE MICHIGAN DNR is looking for private landowners with at least 40 acres of property in the northern Lower Peninsula that are willing to enroll their land in the Hunting Access Program. Landowners have the ability to choose which types of hunting are allowed on their lands. Hunting options are all hunting, youth and apprentice hunting only, small game hunting only, deer only, turkey only, or elk only. Property owners enrolled in HAP receive annual payments of up to \$25 per acre. Almost 20,000 acres are currently enrolled in the program. # **Pacus Caught By Anglers**

THE DNR received reports of three South American red-bellied pacus caught by anglers in southeast Michigan during July. Two were hooked in Lake St. Clair and the third near Port Huron. Pacus are popular aquarium fish that have human-like teeth for eating nuts and seeds and are thought to have been released into the wild by aquarium owners when the fish got too big. Releasing any live fish in state waters without the permission of the DNR is illegal. The exotic fish are not expected to survive the state's cold winters.
